**Smart Growth Tour**

In 1997 Governor Parris N. Glendening proposed and the General Assembly adopted the Smart Growth and Neighborhood Conservation Initiatives. ### **About the Speakers**

#### Ann Elsen

Ann Elsen is the Energy Planner for the Montgomery County Department of Environmental Protection. Her recent article on electricity procurement, "Buying Electricity by the Numbers" appeared in the October issue of *Public Management (PM)* magazine. Prior to joining Montgomery County, Ann was the manager of the Maryland Center for Industrial Energy Efficiency at the University of Maryland, and worked as a program manager for the Maryland Energy Administration. Ann has B.S. in Energy Resource Management, a Masters in Financial Management, and is a Certified Energy Manager through the Association of Energy Engineers, with 18 years of experience.

#### Marge Wolf

Marge Wolf is the Deputy Secretary for the Maryland Department of Housing and Community Development. Prior to her appointment, Ms. Wolf served for ten years as the City Administrator for the City of Hyattsville. Her experience also includes ten years as a grants center coordinator and three years in the private sector. She earned a B.S. degree from the University of Maryland.

#### **David Warrington**

Mr. Warrington was awarded with an ICMA Excellence Award for Public Private Partnerships in 2000. He has been the Town Administrator for Cheverly for 9 years and previously served as the City of Bowie's Director of Public Services for 13 years. Mr. Warrington earned a B.A. degree from the University of Maryland.

#### **Bob Spalding, AICP**

Robert J. Spalding, AICP, has been the Chief of Planning for the City of Rockville since 1998 and in a variety of planning positions between 1984 and 1989. He also worked as Planning Coordinator for the Maryland-National Capital Park and Planning Commission for nine years. Mr. Spalding earned a Masters of Urban & Regional Planning from the University of Virginia and a B.A. from the University of Maryland.

#### Robert J. O'Neill, Jr.

For the last two years, Mr. O'Neill has served as President of this nonprofit organization chartered by Congress to improve the design and management of federal, state, and local governments. Since its founding in 1967, the Academy has been at the forefront of efforts to create more efficient, effective, and accountable government. During his tenure as Fairfax County Executive from 1997 to 2000, he oversaw Virginia's largest general-purpose local government with an annual operating budget of approximately \$2 billion and 11,000 employees. Prior to this, he served as City Manager in Hampton, VA, for 13 years. Mr. O'Neill served as Director of Management Consulting Services for the Virginia offices of Coopers & Lybrand and Regional Manager for the Management Improvement Corporation of America. He earned a B.A. from Old Dominion University and an MPA from the Maxwell School of Citizenship and Public Affairs at Syracuse University. His many honors include the National Public Service Award in 1996 and an honorary doctorate of laws from Old Dominion University in 1999.
