JOB DESCRIPTION

General Description of Duties

This position performs difficult and professional work in the Office of the City Manager and the Department of Economic Development of the City of Hamilton, Ohio.

The nature of the work performed requires that a Fellow establish and maintain a close working relationship with other City departments and with the Hamilton business, school and civic community. The position will assist The Economic Development Department in strategies related to revitalizing the urban core. The Fellow will serve as the staff liaison for the City's "Vision Commission" and will work with the "Vision Commission" to develop and promote strategic initiatives.

This Fellow will also work closely with Economic Development staff on various economic development activities including, but not limited to business attraction and retention efforts, grant writing, assist in the execution of economic development agreements, various state and local incentive programs, and brownfield redevelopment efforts.

General Description of Duties

This position performs difficult and professional work in the operations and engineering support in the Department of Underground Utilities of the City of Hamilton, Ohio.

The nature of the work performed requires that a Fellow establish and maintain a close working relationship with other City departments and with selected City consultants. The position will assist in the evaluation of previous studies and modeling of the sanitary sewer system to determine areas of infiltration and inflow to the city sanitary sewer system to develop a plan for remediation of these flows. The position will work closely with staff members to gather and evaluate data and develop strategies to assist the City in compliance issues. Some field work will be required.

This Fellow will also be involved in the development of a storm water master plan. The Fellow will be reviewing data, working with the City's Geographic Information System and conducting field surveys to determine drainage area issues and developing a plan to control these issues.

The Fellow will also work with utility engineering staff on a variety of project related tasks.

This work is performed under the direction and supervision of the Director of Underground Utilities. Considerable leeway is granted in the exercising of independent and professional judgment.

- Reviews previous studies of the Sanitary Sewer System to determine sources of inflow and infiltration upstream of City Sanitary Sewer Overflows
- Assists in preparation of a plan to prioritize areas to target for elimination of inflow

- Assists in the develop of a Storm Water Master Plan to assist city in efforts to control area wide drainage issues
- Conducts field work as required to evaluate area wide drainage issues
- Performs related work as required.
